## **WE GATHER TO LEARN**

### **MINISTRY MADE POSSIBLE**

Janet Chisom, Associate Pastor of Salem Presbyterian Church, spoke about the CEDEPCA trip taken to Guatemala in October. There were 14 participants working on a variety of projects while there. The next trip is in question because of flights being unavailable to that region.

### **RECOGNITION OF BOB AND DUSTY FIELDER AND WILD GOOSE MINISTRY**

Kim Steinhorst, Chair of New Worshipping Communities Workgroup, under Church Development Committee, and Loren Mitchell, Worship Leader for Wild Goose, recognized Bob and Dusty Fiedler for their devotion and work with Wild Goose Ministry.

### **REPORT OF THE MISSION STUDY TEAM**

Melissa McNair King, Chair of the Mission Study team, gave a complete recap of the work of the Mission Study group since January 2018. Their work started with priorities, focus groups, demographic studies, center of the Presbytery, population center, growth projection, and largest trends in listening sessions. She reviewed the new mission statement, how all areas of POP were examined in light of the new mission statement and priorities, the organization of focus groups, and a new vision. Due to time constraints, we were not able to break out into small groups to discuss this report. No vote was taken at this time. Melissa remained after the meeting adjourned to answer questions about the report.

### **Presbytery of the Peaks -- A Vision for a Way Forward Prepared by the Mission Study Team Fall 2019**

#### **Preamble**

We have spent the past year and a half listening to the presbytery, prayerfully seeking the guidance of the Spirit, asking questions, trying out ideas, and seeking to discern a way forward for our presbytery that faithfully reflects who and what God is calling us to be and do. It seems clear to us that the ministers, elders and congregations of our presbytery have a powerful sense of call to be the Body of Christ in and for the world God sends us to serve in the name of Christ. And it seems clear to us that there is a consensus that in order to fulfill that calling we must become a presbytery where all of us are connected in meaningful and supportive relationships through mutual care and shared ministry. We want to establish partnerships and build coalitions that will strengthen every leader as well as every congregation, campus ministry, new worshipping community, and community of faith.

We confess that without love we are noisy gongs and clanging cymbals, and that cut off from Christ we can do nothing. Relationships are at the heart of who we are and what we do, and we want relationships and connections and mutual support to be at the heart of who we are as a presbytery.

## **The Task at Hand**

We believe the way forward for living into this new vision for our presbytery requires nothing less than adopting a radically new paradigm of what a presbytery is and what a presbytery does. We will have to give up our old ways, some of which are near and dear to us, and allow the Spirit to reform and recreate us in ways that will be challenging and demanding. We will need to move away from a paradigm of control and transaction and create a model of connection and relationship and support.

Our current paradigm served the church well in the past. It sees presbytery as an institution which draws resources from its constituents in order to provide a staff with expertise in specific areas and to offer programs and services that are consumed by the ministers, elders and congregations of the presbytery. This paradigm is also a regulatory model which exercises power from the top down and in which presbytery is often seen as the cause of problems rather than the solution to problems.

The new paradigm which we are envisioning sees presbytery as a means for establishing and promoting connections among ministers, elders, congregations and other communities and entities for the purpose of developing partnerships and coalitions through which mission and ministry can be nurtured from the bottom up and in which power and resources are shared at the lowest level possible. The essential role of the presbytery is no longer the provision of programs and services but rather to provide the context and the tools for bringing people and resources together in order to accomplish shared goals through partnerships, coalitions, and other collaborative mechanisms. Such a presbytery will focus on the ministry made possible when congregations, leaders, and other partners collaborate in shared ministry and mission.

## **Warning!**

This transition will not be easy. It will be hard work and ministries and programs that many of us cherish and in which we have been deeply invested will need to be re-envisioned and re-formed if they are to continue. Some programs may not survive the journey through the wilderness and we must own that possibility up front. We will all need to lay aside our personal agendas for the sake of building up a community of trust and mutual respect.

This transition will not happen quickly. We imagine that it will take at least three to five years to get from where we are to where we want to be. It will require a lot of commitment and a lot of work. All of us will need to bear an abundant harvest of all of the fruits of the Spirit: love, joy, peace, patience, kindness, goodness, faithfulness, gentleness and self-control.

## **A Proposal**

What follows is our understanding of what a new Presbytery of the Peaks might look like. We trust that the Spirit will continue to refine and clarify our vision as we move forward.

Becoming a new Presbytery of the Peaks will not happen overnight or with the waving of some “magic wand.” The first step is coming to a consensus on where we are headed. The second step is to identify and call a person to lead us who shares our vision and who has gifts and skills to help us make our vision a reality. We expect that this second step alone will take a year to complete and that we will need three or four years with this person on board to see the new presbytery take shape.

## **Commissions and Committees**

The following commissions and committees will facilitate the multiple and varied partnerships within the Presbytery of the Peaks and with the wider church:

### **I. The Pastoral Leadership Commission (PLC)**

1. The PLC, composed of 15-21 teaching and ruling elders, representing each of the six neighborhoods, will partner with congregations seeking pastoral and certified educational leaders, including PCUSA Ministers of Word and Sacrament in both installed and temporary relationships, commissioned pastors, certified educators, as well as ministers of other denominations with whom we are in full communion or who are approved by the presbytery's credentialing process.
2. The PLC will provide a framework and process to appropriately welcome, introduce and integrate new pastoral leaders and educators into the presbytery's networks of relationships and partnerships;
3. The PLC will provide a framework and process for supporting pastoral leaders in conflict, personal, family or professional crises, and in discerning their calls in times of transition, such as a new call, retirement, or life-changing events.
4. The PLC will direct the presbytery's ministry to individuals sensing a call to the Ministry of Word and Sacrament, including welcome, nurture, discernment, and support, and coaching Sessions and congregations in their ministry to inquirers and candidates, from inquiry to certifying candidates ready to receive a call.
6. The PLC shall have the authority to act on behalf of the presbytery in all matters pertaining to candidacy, establishing calls, approving contracts, and commissioning or installing pastoral leaders, as well as validating ministries outside congregational ministry. All such actions shall be reported to the presbytery.

### **II. The Community Partnerships Commission (CPC)**

1. The CPC, comprised of 10-15 teaching and ruling elders, representing each of the six neighborhoods, will facilitate vital connections among particular congregations, worshiping communities, campus ministries and other faith communities, including ecumenical partners and partners in the wider PCUSA, that serve to strengthen the witness of the church.
2. In facilitating the partnerships and relationships that form the foundation of our shared mission and ministry, the CPC will make use of neighborhoods, as well as the natural affinities that result from congregational size, context, or common interests, in building relational and ministry networks within the presbytery.
3. The CPC will direct the presbytery's funding of collaborative initiatives that are proposed by two or more teaching elders, commissioned pastors or certified educators. Proposals should strengthen, support, connect, or otherwise develop the pastoral and educational leaders of our presbytery.
4. The CPC will direct the presbytery's funding of collaborating partners whose proposals shall serve to strengthen the witness of the church within our bounds, where two or more collaborating partners (sessions, ecumenical partners, community ministries) come together in common vision or cause.
5. The CPC will have the authority to act on behalf of presbytery in the following matters: receiving and approving grants; merging congregations or forming ecumenical partnerships; starting new worshiping communities and new churches within the bounds of the presbytery. All such actions shall be reported to the presbytery.

### **III. Justice and Mercy Commission (JMC)**

1. The JMC will be comprised of 10-15 teaching and ruling elders, representing each of the six neighborhoods.
2. If the purpose of the presbytery is to build partnerships that strengthen its various communities of faith to be the Body of Christ for the world, the JMC shall lift up the needs of the world to the presbytery as well as Christ's call to join him in the healing of the world.
3. The JMC's principal tools will be education, advocacy, and the allocation of presbytery mission funds to challenge and enable ministry partners to do together in mission what they cannot do as effectively or faithfully when acting alone.
4. The JMC shall oversee the Two Cents a Meal Hunger offering, directing funds to those who demonstrate a commitment to work with local or regional partners in ministering to the hungry.
5. The JMC shall have the authority to act on behalf of presbytery in the following matters: approving grants. All such actions shall be reported to the presbytery.

### **IV. The Trustees**

1. The Trustees will be comprised of 10-15 teaching and ruling elders, representing each of the six neighborhoods.
2. The Presbytery shall regard its collective financial, human and material resources as a gift of grace, entrusted to us by God for the common good and ministry of Jesus Christ, and shall regard itself as an accountable steward of God's gifts.
3. The Trustees will develop appropriate means of receiving, managing, and disbursing the presbytery's real properties, investments, annual and restricted funds, and offerings to the higher councils of the church.
4. The Trustees will develop appropriate means to hire, support, supervise, and pay staff, whose primary task will be to support the ministries that arise from the presbytery's relationships and connections.

### **V. Constitutional Ministries Committee (CMC)**

1. The CMC will be comprised of 10-15 teaching and ruling elders, representing each of the six neighborhoods.
2. The CMC shall maintain the following committees and commissions required by the Book of Order, including nominating to the presbytery individuals to serve, and insuring they are appropriately trained and deployed.
  - a. Permanent Judicial Commission
  - b. Committee on Representation
3. The CMC shall develop appropriate means of drawing leaders into the presbytery's ministries, and the higher councils of the PCUSA, nominating individuals to serve on commissions and committees, and as officers of the presbytery, mindful of the Presbytery's fundamental commitment to inclusion and representation in all the councils of the church.
4. The CMC shall be responsible for fulfilling the following constitutional requirements:
  - a. Sexual Misconduct Policies, Boundary Training, and the various personnel teams required to respond to accusations of sexual misconduct.
  - b. To develop a process for receiving, communicating and implementing mandates or suggested programs, emphases or studies from the higher councils of the church.



- c. To receive overtures from the General Assembly, and lead the presbytery in consideration of and voting on overtures.
- d. To apprise Sessions of the process for submitting and advocating for overtures to the presbytery or higher councils, and to equip them to do so.

## **VI. Presbytery Assembly Planning Committee (PAPC)**

1. The PAPC will be comprised of the moderators of the presbytery's five commissions/committees, the moderators of Presbyterian Women and Black Caucus, the presbytery's Moderator and Vice-Moderator, and the Stated Clerk. At-large members shall be elected from any neighborhood that is not represented by the previous positions. The PAPC can include others whose expertise they desire (who will serve with voice but not vote), and additional staff support as may benefit the committee in its work.
2. The PAPC is responsible for planning presbytery assemblies each year, fulfilling the presbytery's intention to focus on education, fellowship, and the conduct of essential business.
3. The PAPC will be responsible for identifying and coordinating with host sites for presbytery assemblies, and for approving budgeted expenditures for each presbytery assembly.

## **The Presbytery Staff**

The following staff model embodies the presbytery's mission and priorities, namely:

- To promote relationship--building between Ministers of Word and Sacrament
- To connect congregations and worshiping communities with each other in shared ministry
- To encourage leadership through preparing men and women for ministry and helping congregations in conflict and transition
- To strengthen the network of connections digitally throughout the presbytery, lifting up local engagement to the regional level

## **I. GENERAL PRESBYTER**

This position is principally administrative, providing leadership and oversight for the daily and occasional needs of the presbytery office, local congregations, and pastoral formation and transition. It is best served by a Minister of Word and Sacrament, familiar with the issues before the Church and its polity and governance.

## **II. NEIGHBORHOOD PRESBYTER**

This position seeks to strengthen the presbytery's members and ministries through communicating, connections, and education, emphasizing partnerships among the congregations by building relationships of love, care, and mutual support through a network of active neighborhood groups.

This position should be full--time and ordained for the following purposes:

- The future success of mid--councils will depend upon relational coordination among pastors and churches. The foundation of our partnerships, strengthened by neighborhood participation will need committed, focused attention at a presbytery level.
- An ordained Minister of Word and Sacrament will have training and experience in leading worship, pastoral care, leadership and outreach. This will be helpful when serving as a resource

to the neighborhoods, or when called upon to preside over sacraments or moderate meetings for congregations or councils.

### **III. NEIGHBORHOOD CONNECTORS – 6 Part-Time**

Recognizing the geographic breadth of this presbytery and the limits of a single neighborhood presbyter in equipping the networks necessary to fulfill our mission, each neighborhood shall have a paid connector, providing an estimated average of three hours per week, with a monthly stipend. Ruling elders, Ministers of Word and Sacrament, or other qualified leaders will be eligible to serve. Working closely with the Neighborhood Presbyter, their primary duty will be to shepherd the relationships within their neighborhood and to conduct the necessary administrative tasks that may grow out of the partnerships within the neighborhood.

Should the responsibilities grow beyond 3 hours per week in a given neighborhood, the Trustees may authorize up to an additional 3 hours per week, upon the recommendation of the Neighborhood Presbyter and authorization of the General Presbyter.

### **IV. JUSTICE AND MERCY EDUCATOR AND ADVOCATE - PT**

This position will support, coordinate and oversee the ministry of the Justice and Mercy Commission, working with that Commission to foster partnerships within the presbytery that will challenge and equip our congregations and other communities of faith in being the body of Christ for the world.

### **V. STATED CLERK - PT**

The Stated Clerk is an elected officer of the presbytery and its primary constitutional expert, including matters pertaining to the higher councils of the church, judicial procedures, and Presbyterian polity and order. He or she shall serve as a resource to the presbytery's commissions and committees when requested, as well as its Sessions and their clerks, in matters pertaining to the Book of Order. He or she will be the principal staff resource to the Constitutional Ministries Committee.

The Stated Clerk is responsible for the constitutionally required rolls, records and minutes of the presbytery and for reconciling the presbytery's records with those of the Synod and General Assembly.

### **VI. FINANCIAL AND OFFICE ADMINISTRATOR (FOA) – FT**

The FOA will administer the fiduciary responsibilities of the presbytery, oversee the daily functions of the presbytery office and support staff, serving as a resource to the Trustees and to the General Presbyter.

### **VII. ADMINISTRATIVE ASSISTANT (AA) – FT**

The Administrative Assistant shall serve as the face and voice of the presbytery office, receiving guests, directing phone calls, and providing the necessary support to host committee and commission meetings in the presbytery office.

The AA shall be the primary administrative support to the Pastoral Leadership Commission and Presbytery Assembly Planning Committee.

Working with the Technology and Communications Director, and the FOA, the AA will be responsible for presbytery wide communications, including presbytery minutes, digital publications such as Peaks Postings, etc.

### **VIII. TECHNOLOGY AND COMMUNICATION DIRECTOR (TCD) – PT**

The TCD will be responsible for developing and maintaining technological and communication systems that will serve the presbytery and its neighborhoods in their educational, missional, and relational ministries, and to assist, as requested, congregations or presbytery communities in developing their web presence and/or outreach.

#### **Office Requirements and Location**

1. The Presbytery Office is a home base for the presbytery staff, important and perhaps essential to its work as a team of presbytery servants, but it will not function as a “presbytery center” or central gathering place.
2. Designated offices for the general presbyter, financial and office manager, and administrative assistant will be required, along with sufficient space for storage of presbytery files and records.
3. A shared office space (s) for the neighborhood presbyter, stated clerk, justice and mercy advocate, and technology director could be useful, knowing that their primary work is outside the presbytery office in the various neighborhoods and congregations of the presbytery.
4. Neighborhood Connectors will have an office in a church within its bounds, and the presbytery will support such offices with the necessary technology and office supplies to facilitate their work.
5. The Presbytery Office should have at least one conference room where the staff can gather, as well as a break room or hospitality room for hosting small gatherings in the conference room. The Presbytery will no longer maintain a central resource center. Nor will the presbytery office serve as a location for large or multiple committee meetings. Local congregations will become the host of presbytery’s committees and partners.
6. Because the Presbytery office will be a relatively low traffic office, primarily a gathering space for staff and for the safe keeping of files and records, a relatively central location will be helpful as a launching point for the staff’s travels.

### **REPORT OF THE EXAMINATIONS COMMITTEE**

Bob McLavey, Chair of the Examinations Committee presented one candidate to the Presbytery. Rev. William Strong, Stated Supply at Bethlehem and Douglas Presbyterian Churches  
The Examinations Committee Report was received and its recommendation was **Approved**.

## **Biographical Statement**

### **Rev. William Strong**

I was born in 1963 in the Air Force base hospital in Cheyenne, Wyoming, and moved around a great deal growing up. I remember living in Arizona, Texas, Colorado, Mississippi, Ohio, Virginia and the UK. I'm sure there are a few places I don't remember.

My father is a retired FBI agent living in Thailand. My mother is a former teacher and retired paralegal living outside Charleston SC. My parents have been divorced since the mid 80's and are both remarried. My sister is a Special Ed teacher in Atlanta. Her husband died last August after a brief battle with cancer.

My mother raised my sister and I in the southern Presbyterian Church so I am cradle Reformed though the longer I am a Christian the more I draw upon the theological heritage of the Early Church—much as the Reformers did themselves. I have always felt a call to ministry and when I was laid off in the 2008 recession I applied to seminary.

I attended Union Presbyterian Seminary from 2010-2014 and graduated with a Masters of Divinity. My fourth year in seminary was spent as a hospital chaplain at VCU Medical Center. While at seminary I served as the coordinator for the Society for Patristic and Medieval Studies (S.P.A.M.), was chapel and worship coordinator for the seminary during my second year and also received the Hammond Award for Preaching and Worship.

My ministerial experience includes hospital chaplaincy, interim ministry, Christian Education, Spiritual Direction and short term crisis counseling. I have designed and led adult and intergenerational worship and education at my home church in Charlottesville, at a UCC congregation in Richmond where I served as interim pastor, and in the two Presbyterian churches I currently serve. All of this in addition to leading Sunday worship, preaching, teaching, and visiting.

I believe in the importance of ongoing growth and education so I take courses and workshops as they fit into my schedule. Such topics include studying Barth and the Bible online through Pittsburgh theological, Muslim/Christian Relations at Union Presbyterian, and a two year course in Spiritual Direction through Richmond Hill RUAH School of Spiritual Direction in Richmond VA (currently half way through the first year). I am also a struggling iconographer and meet with an Orthodox priest once a week for prayer and studio time.

I also believe in the importance of supporting the church both as the body of Christ and as an institution. In 2018 I stepped down from a three year rotation on the Church & Ministry Committee for the Shenandoah Association of the Central Atlantic Conference of the United Church of Christ. In other words, I have sat where you sit. I have also been a bartender, a bouncer, a busboy, a data base programmer, a process analyst and performance improvement expert, a door-to-door encyclopedia salesman and a dishwasher.

At the beginning of my third year in seminary the Clerk of Session at Douglas Presbyterian Church reached out to the seminary Office of Supervised Ministry and Vocational Planning. My faculty adviser was the director of that office and sent me to Prince Edward county to serve Douglas and Bethlehem with the admonition "Don't upset the Colonel!" At the end of what was supposed to be a one year position the churches asked me if I would stay until graduated. A year later as graduation approached the churches asked me if I would stay until I received my first call. A few months later the churches asked if I could stay. It's been financially tight but spiritually rewarding. 6 years later, I'm still here.

**Faith Statement**  
**Rev. William Strong**

This I believe...that the birth, life, death, resurrection, ascension and return of Jesus Christ is the pivot on which all of history and all of creation turns. In his birth Jesus renews God's graceful declaration that all of creation is "very good" and reveals the depth of God's love for all.

This I believe...that in his life Jesus shows us a God who loves us so much that God takes on human flesh to walk and work and weep among us, to cast out our evils and heal our wounds and forgive our sins, and to call us into the beloved community of his Body to do the same today.

This I believe...that on the cross Jesus took the worst human beings have to offer and returned the best God has to give. I believe that in the dying and rising of Jesus Christ, God has set us free from Sin, Death and the Devil and that we are indeed free – free to choose whom we serve.

And this I believe...that God's Word is more than just a book, no matter how inspired a book we may believe it to be. God's Word is a mysterious and mighty presence before whom I bow down and worship. I do not search God's Word. God's Word searches me. The searching continues.

For PASTORS, CO-PASTORS, AND ASSOCIATE PASTORS

***Approved November 21, 2019***

1. Changes in the minimum terms for 2020 include an increase in minimum cash salary of 1.6% based on the 12 month Consumer Price Index as of June 30, 2019.
2. For 2020 the Board of Pensions (BOP) will continue to offer one medical coverage rate billed at 25% of effective salary. This provides full medical coverage for spouses and all family members. The minimum basis for effective salary for medical coverage remains at \$44,000 for 2020. Total 2020 BOP dues for medical, pension, and death/ disability insurance will remain at 37%.
3. The Terms of Call blank forms ( in pdf format) as well as an Excel Spreadsheet will be available on the Presbytery website ([www.peakspresbytery.org/Resources/Forms](http://www.peakspresbytery.org/Resources/Forms) & Documents/COM).



4. The Complete Minimum Financial Terms Policy is available on the Presbytery website ([www.peakspresbytery.org/Resources/Forms](http://www.peakspresbytery.org/Resources/Forms) & Documents/COM) or by calling the Presbytery office (434-845-1754 or 1-888-557-3257)
5. Churches must use Benefits Connect – the BOP internet on-line system - to establish terms of call information for new pastors or change information for existing pastors. Changes in Terms of Call must be reported within 30 days of the effective date.
6. Churches report the Terms of Call to COM after the congregational meeting.
7. **Minister mileage reimbursement rate is the IRS business mileage rate for 2020. The current reimbursement rate is \$.58 per mile. The 2020 rate will be set in mid-December 2019.**

1. Manse Rental Value is 30% of the Base Cash Salary and other compensation if provided.
2. Housing Allowance minimum suggested amount is \$12,000 including utilities.

4. Other compensation would include items such as 403(b) contributions by the church, payment of optional insurance coverages such as dental or life insurance and SECA payment in excess of 50%.
5. SECA (Self Employment Tax) is based on the effective salary amount. The rate for SECA is 7.65%.

9. Travel Expenses paid at the IRS Business Mileage reimbursement rate for the year. The rate is set by the IRS in mid-December. The current rate is \$.58 per mile.

2. Recommend the Presbytery grant permission to Richard Henderson, Missional CP, to moderate the Congregational Meeting of First Presbyterian Church, South Boston on Jan. 5, 2020 for the purpose of electing new elders. **Approved**
3. Recommend the Presbytery approve the formation of an Administrative Commission for the dissolution of R.D. Holmes Memorial Presbyterian Church and Trinity Presbyterian Church, Ridgeway. The Administrative Commission will include: Naomi Hodge Muse, CP, Grace Presbyterian Church; Kym Wiederholt, RE, First Presbyterian Church, Collinsville; Rev. David Baker, Stated Supply, Williamson Memorial Presbyterian Church; and Rev. John Wiederholt, Stated Clerk. **Approved**

**REPORT OF THE ADMINISTRATIVE COMMISSION FOR  
GREEN RIDGE AND NORTHMINSTER PRESBYTERIAN CHURCHES  
ROANOKE, VA**

Ed Soto, chair of the Administrative Commission, presented the report and the three recommendations were **Approved**.

**Defining Dissolution, Assimilation, and Merger**

The Presbytery has a responsibility to oversee a smooth transition when a church deems its mission and ministry as no longer viable. When a Session concludes a proper call to stewardship is to close their doors, the Presbytery has a duty to enumerate the options that lay ahead. While many churches heretofore have closed under one of the following three systems, no definitions have been in place at the Presbytery level. Therefore, a church that wishes to close may dissolve, assimilate, or merge.

The dissolution of a congregation occurs when a church ceases operation and no longer exists as a worshipping community. The name and employer identification number are considered no longer active. The assets of said church are liquidated and first used to resolve any outstanding debts, then the remainder of the assets are transferred to the Presbytery to be disposed as necessary. The minutes of this congregation are transferred to the Presbytery for keeping and the membership is shepherded under other congregations.

The assimilation of a congregation occurs when a church ceases operation as an independent entity and is assimilated into another congregation. The name and employer identification number are considered no longer active. The assets of said church are either liquidated and used to resolve any debts and transferred to the adopting church, or all assets and liabilities are transferred to the ownership of the adopting church, as is, to be utilized or disposed of in accordance with the mission of the congregation and to the glory of God. The minutes of the assimilated congregation are transferred to the Presbytery for keeping and the membership is transferred to the adopting congregation.

A merger occurs when independent congregations unite into a newly minted church. The two or more merging churches combine operations into one worshipping community. The name and employer identification numbers of the merging churches are erased and a new name and

EIN are created. Any outstanding debts from any of the merging churches need be paid and all remaining assets and liabilities are transferred to the new congregation to be disposed of as necessary. The minutes of the merging congregations are kept at the new church and the membership is adopted into the new church.

The process for all of these begins the same way, with a Session announcing to the Presbytery its desire to dissolve, assimilate, or merge. An Administrative Commission is established as needed and shepherds the Session(s) through the process as traditionally done.

### **Considerations**

Whereas Green Ridge Presbyterian Church, Roanoke, founded in 1956 and having served faithfully in ministry for 63 years;

Whereas the members, elders, pastors, and other leaders of the congregation have used their gifts to proclaim the Gospel;

Whereas the congregation has over a number of years experienced a decreasing and aging membership;

Whereas the Session at a stated meeting in March 2019 voted to request that Green Ridge Presbyterian Church enter into a period of discernment with Northminster Presbyterian Church, through a transition task force, and the Presbytery, through an Administrative Commission, to determine the future of the congregation;

Whereas, in response, the Presbytery of the Peaks, at the One Hundred Twenty-First stated meeting, approved an Administrative Commission to “assist the Sessions of Green Ridge Presbyterian Church and Northminster Presbyterian Church in finalizing the terms of assimilation” and “recommend to the presbytery the assimilation of Green Ridge Presbyterian Church and the disposition of real and personal property associated with it;”

Whereas the Session of Green Ridge Presbyterian Church deemed it of highest importance to complete this process before winter 2019;

Therefore, the Administrative Commission offers the following recommendations.

### **Recommendations**

Pursuant to the definitions cited above, the Administrative Commission recommends

(1) the Presbytery approve the assimilation of Green Ridge Presbyterian Church into Northminster Presbyterian Church effective December 31, 2019. **Approved**

(2) The Presbytery approve the transfer of all membership rolls, financial assets, appurtenances, furnishings, and real property of Green Ridge Presbyterian Church to Northminster Presbyterian Church, held in trust for the mission of the PC(USA), and used in

accordance to the ministry of Northminster Presbyterian Church and ultimately to the glory of God; **Approved**

(3) The Presbytery approve the transfer of all Green Ridge Presbyterian Church Session minutes to the Presbytery office. **Approved**

### **REPORT OF THE ADMINISTRATIVE COMMISSION FOR PROVIDENCE PRESBYTERIAN CHURCH, NATHALIE, VA**

Kym Wiederholt, chair of the Administrative Commission, presented the report with the recommendation being **Approved**.

The Session of Providence Presbyterian Church, of Halifax County, Virginia, is requesting dismissal from the Presbytery of the Peaks (POP) and its parent denomination, the Presbyterian Church, U.S.A. (PCUSA), said dismissal to include transfer of the congregation to the Evangelical Presbyterian Church (EPC).

As of December 31, 2018, it is understood that the congregation has:  
58 active members; an original church building built in 1925 with additions and quality improvements; a manse built in the 1960's-1970's; a cemetery; land consisting of approximately 8.6 acres with a total appraised value of \$405,000; and approximately \$172,918.70 in cash, investments, and savings assets.

Based on this information, and numerous discussions and meetings between the Session and Presbytery's representatives, as well as a meeting with the congregation for a straw poll, all relevant parties now agree to this dismissal and transfer with the following conditions:

#### **The Presbytery of the Peaks agrees to:**

- 1) Dismiss and transfer Providence (Halifax) Presbyterian Church to the Evangelical Presbyterian Church as so requested by the Congregation by a unanimous vote of active members present at its April 7, 2019 meeting;
- 2) The proposed date of dismissal would be December 31, 2019, with a "commissioning/dismissal service" to be conducted by the Presbytery prior to dismissal;
- 3) Include in this transfer and dismissal all properties, facilities, financial and other assets, and membership;

4) Cede to the congregation any rights to the name “Providence Presbyterian Church” in Halifax County, Virginia, given the understanding that the identity of the congregation has been with the PCUSA and/or its antecedent bodies for over 188 years and with the stipulation that the new name for the congregation be established which includes the name of the denomination to which it is being dismissed;

**Providence Presbyterian (Halifax County) Church, including Session, Trustees, and membership upon its request, agrees to:**

1) Work with the Stated Clerk of the Presbytery to receive written confirmation from the Presbytery of the Mid-Atlantic of the Evangelical Presbyterian Church that the transfer is acceptable should the way be clear and all agreements are accepted in this document.

2) Pay to the Presbytery of the Peaks (POP) in recognition of the ministry and support provided to the church as a member of the Presbytery and its antecedent bodies the following:

1. Based on the tax assessment of the building and property value and current financial assets as well as ongoing support of Presbytery Mission and Ministry an amount of *Eighty-two Thousand Eight Hundred Ninety-five Dollars (\$82,895)* to be paid over a ten-year period at annual amount of *Eight Thousand Two Hundred Ninety (\$8,290) for nine years with a final payment of Eight Thousand Two Hundred Eighty-five Dollars (\$8,285)*;
2. If the congregation chooses to pay the total amount of *Eighty-two Thousand Eight Hundred Ninety-five Dollars (\$82,895)* by December 31, 2019, a Five Percent (5%) deduction will be applied making the total amount due *Seventy-eight Thousand Seven Hundred Fifty Dollars and twenty-five Cents (\$78,750.25)*.

3) The total amount of *Eighty-two Thousand Eight Hundred Ninety-five Dollars (\$82,895)* will be paid over a *Ten Year (10)* period according to the following schedule:

- 4) The Presbytery of the Peaks shall not charge the Providence (Halifax) Church interest on the unpaid balances due. The Providence (Halifax) Church shall have the right of prepayment in part or in full without Presbytery asserting a penalty;
- 5) That prior to actual dismissal Providence (Halifax) Presbyterian Church agrees to elect and have registered in the county courthouse a board of trustees to serve as officers of the congregation in its new denomination;
- 6) Provide the Presbytery of the Peaks Stated Clerk with all original records of session and congregational minutes, membership rolls, and the like, as requested, to be maintained in perpetuity at the Presbyterian Historical Society in Philadelphia. Arrangements may be made through the Stated Clerk for micro- filming and digitizing records by the Presbyterian Historical Society if the Session would like originals to be returned. All costs for these services will be provided by the Session;
- 8) To assure that the congregation settles down in its new denominational home the Presbytery of the Peaks shall retain a right of reverter\* for ten years upon the real property of the congregation, such right to be exercised should the congregation seek to leave its new home for another denomination or independency or should the congregation fail to fulfill all the agreed to obligations in this separation agreement;
- 9) That Providence (Halifax) Presbyterian Church agrees to reimburse the Presbytery of the Peaks all costs for the transfer of deed(s) with the inclusion of the right of reverter.

\*Definition of the Right of Reverter: A right of reverter gives an organization the opportunity to resume ownership of property when that property is not being used in accordance with the requirements laid out upon the transfer of the title of that property. The Right of Reverter shall be retained and may be exercised with Providence (Halifax) Presbyterian Church as stated above if the conditions of the agreed-to obligations in the mutual separation agreement are not met and/or if the Congregation decides to leave the Evangelical Presbyterian Church.

**Recommendation:**

1. The Providence Presbyterian Church Administrative Commission recommends the Presbytery approve the Administrative Committee Report and Terms of Agreement. **Approved**

**REPORT OF THE TRUSTEES**

4. The Trustees approved the request of the Trinity, New Canton Presbyterian Church to apply for listing on the Virginia Historic Register.
5. Appointed a Nominating Committee to present a slate of officers at the January 2020 Annual Meeting.

**RECOMMENDATIONS:**

1. The Trustees recommend Presbytery approve the request of Westminster Presbyterian Church for the transfer of about one half of the church land area to Habitat for Humanity for use of building 5 or 6 houses. **Approved**
2. The Trustees recommend Presbytery approve the transfer of the Green Ridge Presbyterian Church property to Northminster Presbyterian Church as a part of the blending of the two congregations. **Approved as part of the AC Report for Green Ridge and Northminster.**

**REPORT OF THE COMMITTEE ON ADMINISTRATION**

In 2018, following the departure of several churches and the associated loss of membership, the committee reported that our minority membership had grown to 2.4%, while the percentage of minority members in leadership positions had increased to 12.2% of Presbytery membership.

In 2019, the Nominating Committee has continued its efforts to see that each committee of Presbytery has minority representation. The percentage of minority membership in leadership positions is reported at 17.4%. (This percentage includes people serving on more than one committee.)

## INDEPENDENT AUDITOR'S REPORT

We have audited the accompanying combined financial statements of the Presbytery of the Peaks and the Presbytery of the Peaks of the Presbyterian Church (U.S.A.), Inc. (nonprofit organizations, together the "Presbytery"), which comprise the combined statement of assets, liabilities, and net assets - modified cash basis as of December 31, 2018, and the related combined statements of support, revenue, expenditures, and changes in net assets - modified cash basis, functional expenditures – modified cash basis, and cash flows - modified cash basis for the year then ended, and the related notes to the combined financial statements.
