#### PRESBYTERY OF THE PEAKS STATED MEETING MINUTES Thursday, March 4, 2021; 9:00 a.m. via Zoom

The Moderator, Rev. Steve Willis, called the March 4, 2021 Stated Meeting of the Presbytery of the Peaks to order at 9:00 a.m. The meeting was opened with prayer by the Moderator.

Rev. Carl Utley, our General Presbyter, welcomed the Presbytery, introduced guests, and led the Presbytery in prayer for those we lost in 2020 and those in need presently.

The Stated Clerk declared that a quorum was present and submitted the consent agenda for approval.

#### **Consent Agenda**

No consent items were removed, and the agenda passed by consent:

#### **Report of the Stated Clerk**

- 1. **FOR CONSENT AGENDA:** That the Standing Rules be suspended in order to conduct an electronic meeting via Zoom according to the same rules for electronic meetings adopted at the June 13, 2020 meeting. (The actions of this and similar meetings are subject to ratification at the next regular in-person meeting of the Presbytery when such a meeting can be held safely. It is offered because there is no other way for the Presbytery to responsibly conduct its business during the pandemic.)
- 2. **FOR CONSENT AGENDA**: That the minutes of the November 19, 2020 Stated Meeting of the Presbytery of the Peaks, as reviewed by those persons designated by the Standing Rules, be approved.
- 3. **FOR CONSENT AGENDA:** That Pam Claterbaugh be approved as recording secretary for Presbytery Meetings in 2021.

#### Cabinet

1. **CONSENT AGENDA**- The Cabinet moves the creation of an Administrative Commission (AC) to close Trinity Presbyterian Church Ridgeway, in consultation with the Black Caucus, whose members and Chair shall be identical to the Presbytery of the Trustees.

This AC is delegated the following powers by the Presbytery of the Peaks:

- 1. To assume original jurisdiction of Trinity Presbyterian Church Ridgeway.
- 2. To take possession of all real and personal property, financial records, inventories, historic records and arrange for transfer of title to the Presbytery of the Peaks of all accounts and real property known to be in the possession of Trinity Presbyterian Church Ridgeway.
- 3. To assert claim of the Presbytery to any property of Trinity Presbyterian Church Ridgeway not known at this time or property which may come to Trinity Presbyterian Church

Ridgeway as the beneficiary of a will or trust not known at this time.

4. Power to complete the required and customary steps to dissolve a congregation of the PC(USA), including decisions regarding the marketing and sale of real and personal property.

The Cabinet also moves as part of this motion that the above delegated powers regarding Trinity Presbyterian Church Ridgeway be removed from the existing Administrative Commission tasked with closing both R.D Holmes Memorial Presbyterian Church and that AC be dismissed with thanks.

## First Time Commissioner Orientation Presbytery of the Peaks

If this is your first time as a Commissioner to any Presbytery meeting, please start here. If this is your first time at the Presbytery of the Peaks, but not your first rodeo, you may want to skip the first couple of sections.

#### **Presbytery Meeting Basics**

As a Presbyterian, you probably already know the basics of our system of government, so let me share a few tips you may not realize:

- You are a Commissioner, not a Delegate
  - This means that no one, not your session, not your pastor, not your spouse, can tell you how to vote on a particular issue. That's between you and the Holy Spirit.
  - You are responsible to read all of the documentation before the meeting and be prepared to speak up if you feel you should.
- You may not know who all these people are and what their jobs are, so here's a cheat sheet. Cast of Characters:
  - o Moderator
    - Rev. Steve Willis, the person with the gavel. The Moderator is responsible to make sure the meeting runs well, and is the non-staff leader of the Presbytery.
  - Vice Moderator
    - Elder Helen Dean is the Vice-Moderator and Moderator in waiting. She'll be taking over from Steve next year.
  - General Presbyter
    - Rev. Carl Utley is our Presbytery's pastor and executive. He's the staff numero uno and has a variety of responsibilities throughout the Presbytery, including acting as pastor to our clergy members.
  - Stated Clerk
    - Rev. Dave Baker is the Presbytery's Stated Clerk and Director of Communications. As Stated Clerk he's responsible to help plan Presbytery meeting, prepare the Presbytery Packet, and keep the meeting running "decently and in order", acting as the Presbytery's parliamentarian.
- Presbyterian meetings are governed by Robert's Rules of Order
  - "No? Really?" you say. But yes, believe it or not, the Book of Order directs (G-3.0105) that Presbyterian councils (such as the Session or Presbytery or General Assembly) are governed by Robert's Rules of Order. That doesn't mean you have to be a parliamentary expert to attend meetings, but you should probably learn the basics below if you want the meeting to make sense once business begins.

#### **Robert's Rules Cheat Sheet**

Below is a summary of your rights and responsibilities under Robert's Rules. Generally speaking, these rules are intended to reduce tension, protect the rights and voice of the minority opinion, and of course, keep us doing things "decently and in order" (1 Cor. 14:40, ESV).

- Always address your comments to the Moderator or presenter, never to other commenters
- Generally, don't interrupt another speaker, but wait until you're recognized by the Moderator
  - EXCEPT for these reasons (not exhaustive):
    - You can't hear what's going on or you're so uncomfortable over the room temperature, etc. you can't stay in the meeting (say, "Point of Privilege" then explain the problem)
    - You think something was wrong with what just happened (say, "Point of Order" then state your objection. The chair will then decide if you're right or not.)
    - You want to request information from the speaker (say, "Point of Information" and ask your question. This is NOT an opportunity to give information, but only to request it.)
- Some motions it may be useful to know about:
  - o Call the Question, aka, Move the Previous Question
    - A request to vote on whether or not to vote. This motion requires a second, but isn't debatable. It can only be made after the Moderator recognizes you. Typically it's made when someone thinks we've hit the limit of productive discussion, and we're running in circles.
    - When you hear "Call the Question", be aware that the next vote is not on whatever it is we're talking about, but on whether or not to continue discussion. An affirmative vote will end discussion, and the next vote is on the main motion.
    - To protect the rights of the minority opinion, this motion requires a 2/3rds majority to pass.
  - Amendments to Main Motions
    - If you want to slightly modify the language of a motion, to add, delete or replace some language, you'll want to say "I move to amend the motion..." when the Moderator recognizes you. This requires a second, and will then be discussed and voted on.
  - Substitute Motions
    - If you want to substantially modify a motion on the floor, changing the intent or most of the language, you need to use a Substitute Motion instead of amending the current motion. When the Moderator recognizes you, you'll say "I move the following substitute motion" and read your alternative suggestion. You'll also want to provide a copy to the Stated Clerk in writing.
  - Division of the House
    - If you think that a voice vote was too close to call, any member of the Presbytery may request a "Division of the House" or vote by raised hands or ballot.

- Order of the Day
  - Not a motion, but something you'll see on the agenda, usually related to lunch. All "Order of the Day" means is that we need to drop whatever it is we're doing when the time for that item arrives and start doing the "Order of the Day".
- Not necessarily in Robert's, but please follow these conventions of our Presbytery regardless:
  - When you want to speak, please come to the microphone (or unmute yourself), then state your name, status (clergy or elder) and church.
  - Please read the Presbytery Packet thoroughly before the meeting.
    - Especially, read the items on the "Consent Agenda", as those motions will be passed right at the beginning of the meeting unless you speak up at that time.
    - You should also bring a copy of the Presbytery Packet with you, as there won't be any additional printed packets at the meeting.

#### **Zoom Considerations**

We'll be meeting again by Zoom. If this is your first time using Zoom for a Presbytery meeting, there are a few things to keep mind. For a detailed training on how to use Zoom for Presbytery, please go to this link:

Here are a few highlights to keep in mind:

- Please stay muted unless you're called on by the Moderator to speak.
  - Use the space bar to mute or unmute on the computer
  - Use \*6 to mute or unmute on the phone
- Raise your virtual hand (click on the "Raise Hand" icon under the "Participants" button) to seek the floor, vote, or object to a motion passing via consensus.
  - Use the "Raise Hand" icon in the Participants menu to raise your virtual hand on the computer
  - Use \*9 to raise your virtual hand on the phone

#### Presbytery of the Peaks Special Rules of Order

For Electronic Meetings Using Zoom Technology

#### I. Meeting Types

An "Electronic Meeting" as used in these rules means a meeting at which all participants are joined electronically. It is expected that each participant will attend the meeting individually on a computer or device, rather than one being shared by multiple members. Multiple attendees on a single device requires approval of the chair in advance, and may limit members' rights. Meetings of all boards and committees are authorized to meet electronically at the direction of the chair, provided that all members have access to the necessary equipment.

#### II. Hardware and Software

Electronic attendance utilizes Zoom technology (www.zoom.us). Participation requires high speed internet access on a computer, device or phone. Audio is provided either through the computer, which requires computer audio capabilities (microphone and speakers—preferably earbuds or a headset), or connection by phone. Video is optional, but encouraged. While tablets and smart phones are acceptable, laptop or desktop computers are preferred, because the screen content can become very small on tablets and phones, and only certain portions of the content can be displayed at a time. Using a phone alone is not recommended. Immediate access to email is also a requirement. Notify the Presbytery office if more than 1 voting member is on a device. A text number will be provided to use if there is a divided vote. Prior to the meeting, participants are asked to test their setting at zoom.us/test.

#### **III. Sign-In Procedures**

- A. Prior to meetings, members will receive either a meeting id code or a link to a webpage. Clicking on the link should open a web browser and go directly to the meeting. If it does not do so, or if only the 9-digit meeting id (which is at the end of the link) was distributed, the participant can go to: a <a href="www.zoom.us">www.zoom.us</a>, choose "join meeting," and enter the id manually.
- B. Join the meeting using your full name and title for the First Name field (eg, Rev. John Smith), and your church or status for the Last Name field (eg, First Pres or Honorably Retired)
- C. Members shall make every effort to sign into the meeting sufficiently in advance of the time of the meeting to enable their connections to be verified and, if necessary, assisted by troubleshooting. The following process shall be followed in entering meetings:
- D. If using a laptop or desktop computer, complete a full "re-boot" just before entering the meeting.
- E. Enter the meeting as described in Section III.A. If prompted, download Zoom software and choose to run or install. If prompted, enter your name and choose to enter the meeting.
- F. Choose the method by which you will connect your audio and follow the prompts on the screen. If connecting by computer, check your speakers and microphone to ensure that you can hear and be heard.
- G. Mute your microphone when you are not speaking (on a computer, click on the

- microphone icon to toggle mute. On a tablet or phone, touch the icon), or unmute it only when you are speaking (on a computer, hold the spacebar to temporarily unmute yourself).
- H. On a PC or Mac, click on the "Participants" and "Chat" icons to make those items visible. If a screen share has been initiated and a document is visible in the center of the screen, move the "Participants" and "Chat" windows (by "dragging") to the side of the screen, so that the document is visible.

#### **IV.** Connection Issues

- A. Each attendee is responsible for his or her connection to the internet and the meeting room; no action shall be invalidated on the grounds that the loss of, or poor quality of, a member's individual connection prevented him or her from participating in the meeting, provided that at least a quorum of members was connected and adequately able to participate.
- B. The chair may cause or direct the temporary disconnection or muting of an attendee's connection if it is causing undue interference with the electronic meeting. The chair's decision to do so, which is subject to an undebatable appeal that can be made by any member, shall be recorded in the minutes.
- C. The chair may rule that any meeting be recessed to allow the meeting room to be reset; upon which ruling the meeting shall be ended and a new meeting shall be established with the new meeting id being sent by email or other electronic means to all participants who shall then enter the new meeting room.

#### V. Recognition and Assignment of the Floor

- A. To seek recognition by the chair, a member shall activate the "raised hand" icon. Upon recognition of a member, that member and any others with raised hands activated shall lower them, which may also be accomplished by the host if members do not promptly do so. The chat is not a valid means of recognition.
- B. Another member who claims preference in recognition shall thereupon promptly raise (or raise again) his or her hand icon and the chair shall recognize the member for the limited purpose of determining whether that member is entitled to preference in recognition.
- C. Upon being recognized, a member shall unmute his or her microphone. Upon yielding the floor, the member shall mute his or her microphone.

#### **VI.** Interrupting Motions

- A. A member who intends to make a motion that under the rules may interrupt a speaker (Point of Order, Appeal from the Ruling of the Chair, etc.) shall activate the member's "No" icon (red X). The member shall be recognized to determine the purpose for which he or she is seeking recognition.
- B. In the event that a member intends to make an interrupting motion and is unable to use the "No" icon (eg, phone only user), the member may unmute and make the motion orally. A member may also make interrupting motions orally if not immediately recognized by the chair.

#### **VII. Motion Processing**

- A. A member intending to make a main motion, offer an amendment, or propose instructions to a committee, shall, immediately after being recognized and assigned the floor, post the motion in writing to the chat window.
- B. The secretary assigned by the Stated Clerk is responsible for the display of meeting materials, including all such motions, in the document that is displayed in the shared screen.
- C. When any motion has been stated by the chair, the secretary shall copy and paste it into the document, and shall be responsible for accurately displaying any proposed amendments under consideration, as well as the final version as adopted or rejected. If a second is necessary, the chair shall request a raised hand to indicate a second.

#### VIII. Voting

- A. When the chair seeks unanimous consent on a matter, a raised hand shall constitute an *objection* to unanimous consent, and voting shall then proceed by another method.
- B. Voice votes shall be taken by means of the raised hand function. The chair shall ask those for a motion to raise their hands and the chair or a host shall take an approximate count those in favor and lower their hands before the chair proceeds to the against vote, which shall be conducted in like manner. Phone only participants may raise their hands by pressing \*9. This vote shall be deemed a Division (not a counted vote). A call for a division shall therefore not be in order following such a vote.
- C. Counted votes, when ordered by the chair or the assembly, shall be taken in the same manner as voice votes above in section VIII. B., but with an exact count of for and against votes. If there are no phone only participants, votes may be counted using the Zoom polling feature instead.
- D. A roll call vote may be ordered by the assembly.
- E. No secret ballot votes are in order if there are phone only participants. If everyone is participating using a computer or device, secret ballot votes may be taken using the Zoom polling feature, provided that the poll is set to be anonymous.

#### IX. Roles

- A. There shall be three designated roles with specific duties, any or all of which may be accomplished by one individual, at the discretion of the chair: the host/co-host(s), the chair, and the secretary.
- B. The host/co-host(s) shall initiate the meeting, and therefore have control of the various features for meeting management such as the ability to manually mute one or more participants and clear status icons (raised hand, Yes, No, etc.).
- C. The chair shall preside at the meeting. In addition to normal duties, the chair shall direct the host and secretary as necessary related to their duties in these rules.
- D. The secretary shall keep a record of meeting, including a video recording.

#### Biographical Statement Rev. Ben Brannan

I grew up in Rock Hill, SC in a family that was very active at Oakland Avenue Presbyterian Church. Sports and church were the main focus of our household. My family was very involved in not only the church but the community as well. This has shaped my understanding of service.

Religion and spirituality were two ordinary things in my life growing up. But it is quite providential how the ordinary is painted with the divine when we take a second to recall and reflect. I would say my faith journey is one of 'becoming'—perfectly imperfect in Christ and living into this truth of identity.

Following a career change—moving from the YMCA camping industry and coaching to corporate communication sales—I found myself reflecting on what truly matters in life. There was a void in the work I was doing, and the missing piece was connection. I yearned for interactions that were grounded in more than transactional interest that moved each party to new understanding. I found this in the church work I was involved in—youth, session, and fellowship committee. This is when God began to speak.

I heard my calling through my growing involvement church programming. As part of the "Together On Wednesday" program, I proposed a youth class on Reformed Theology, hoping to teach (and learn) church and Presbyterian history and basic understandings of reformed faith. This was cool! I was excited to learn, energized to teach, and found joy in the moments of connection. God spoke to me through other people. I was ordained as an Elder, served as a youth advisor and co- interim youth director. Others witnessed a transformation in me, and I was encouraged and challenged to consider a move into ministry to seek theological education. I wanted to learn more.

Upon acceptance to Austin Presbyterian Theological Seminary, I began to envision what this all means. Upon reflection, this formative opportunity was my exodus comfort allowing me to fully listen for my call and my identity. Prior to leaving for Austin, I met my now wife and this relationship led me to transfer to Union Presbyterian Seminary in Richmond. Again, this transition helped shape my calling and my identity as a person and as a disciple of Christ. Seminary was challenging in many ways; it was a time of vulnerable and deep engagement with others, myself, and with God.

God speaks in various ways, and we must still ourselves enough to hear and listen. My passion lies in equipping and empowering sisters and brothers in Christ to feel confident and be able to make a positive influence in their world. I believe we are called to respond to the saving love of God by building a community of equality and inclusion, by joining together as we love and serve each other and God, and by sharing the Good News. It brings me great joy to walk alongside those whom God has called me to serve, using my passion for preaching, my joy in intergenerational connections, and my creativity in forming partners in the work of Christ.

## Statement of Faith Rev. Ben Brannan

God's grace is the beginning and the ending of everything. In love, God created humanity to share in God's love and enjoy God's creation of the heavens and the earth. In response, we are called to follow God's Word in faith and to serve and worship God with our whole selves. Humanity was created in perfect relationship with God, but we have fallen from God's perfect purpose and have become estranged and separated from God.

However, because of God's love we have been reconciled in Jesus Christ. Jesus Christ is God incarnate, given life by the power of the Holy Spirit. Jesus walked the earth full of grace and truth. He challenged societal and cultural structures, and he was persecuted and crucified for his ministry. Jesus died. On the third day he rose from the dead. I believe through faith we are made new. I also believe that human failures come throughout life, but by God's grace and mercy we are encouraged and strengthened to grow more and more like Christ. I believe that in death we are raised to be with God in Paradise. One day there will be a new heaven and a new earth. My hope and prayer is for all to receive eternal life. To God be the glory, now and forever. Amen.

#### **Boardlink**

Starting with the March invoice, the Board will no longer mail invoices via the US Postal Service. *Beginning March 1<sup>st</sup> all invoices will be delivered electronically via BoardLink* (our online billing process). Have your employer representative, or the person responsible for paying bills at your church, go to <a href="https://www.pensions.org">www.pensions.org</a> and look for *BoardLink* on the landing page. Click the link and find instructions for registering.

Why the change? a) timeliness of delivery; b) safety of church and Board church employees; c) environmental stewardship; d) security of transactions. The February invoice will be the last one to be mailed. Your billing person may have seen physical and electronic communication already about this change and completed the signup.

#### Minister's Choice

The Board of Pensions continues to provide employers with more choices, and to serve more ministers with benefits that support wholeness. Ministers of the Word and Sacrament who are NOT in installed pastoral positions and have access to healthcare from other sources can be enrolled in this new package which includes all the income security available in *Pastor's Participation* (Pension, Death and Disability, Temporary Disability, and access to the Retirement Savings Plan) without the cost of healthcare coverage.

Minister's Choice also includes access to the Board's Education and Assistance programs (like *CREDO* and *THRIVE*) at just 10% of Effective Salary (employer-paid). Call me to find out if this package could be a good fit for your pastor and congregation.

#### ESI - Express Scripts

Express Scripts is the new administrator for the **prescription drug program** for those with medical coverage through the Board of Pensions, effective January 1, 2021. We know transitions can be frustrating and it takes extra effort to set up your account with a new provider. We are here as your advocate to help work things out. Call us.

#### **Temporary Disability**

This new benefit from the Board became available January 1, 2021. It's included in the Pastor's Participation and Minister's Choice packages, and available to other employees working 20+ hours, at their employer's discretion (either employer or employee paid).

#### **Benefits Connect information**

Don't forget to update church and employee information!!

- Pastors and all employees in a Board plan check your contact, benefit and beneficiary information through your Benefits Connect portal.
- Church Employer Representatives (treasurers/administrators/personnel chairs): Check that the right people and their contact information are up to date in the church account. Update Terms of Call and other employees' salary or other changes, through the church's Benefits Connect portal.

## Changes to benefit offerings for 2021

The Board of Pensions has announced changes to the Benefits Plan that extend support to more ministers and add benefits that promote financial protection for all church workers effective January 1, 2021. Employers can choose benefits for 2021 beginning July 20.

#### Minister's Choice benefits package added

To address the Board of Pensions' concern that too many ministers are not enrolled in the Benefits Plan, the 2021 plan offers two benefits packages for PC(USA) ministers: the existing Pastor's Participation and the new Minister's Choice.

Enrollment in Pastor's Participation, a comprehensive benefits package with medical coverage and pension participation, is required for installed pastors and may be offered to any minister with a minimum 20-hour workweek. Dues, paid in full by the employer, will remain at 37 percent of effective salary for 2021, with no reduction to existing benefits and the addition of the new Temporary Disability Plan.

Minister's Choice, available for non-installed ministers working at least 20 hours a week, includes pension, death and disability, temporary disability, and the Employee Assistance Plan. The cost is 10 percent of effective salary, also fully employer paid.

Minister's Choice also opens the door for eligibility to assistance and education programs that have been available only through Pastor's Participation, such as CREDO and Minister Educational Debt Assistance.

#### **New Financial Protection Programs**

For 2021, the Board of Pensions has added financial protection options, including the Temporary Disability Plan, Long-Term Disability Plan, and an expanded term life benefit.

The Temporary Disability Plan provides a partial weekly income for up to 90 days of disability, with a 14-day waiting period before benefits payments begin. Employers pay the full cost for ministers enrolled in Pastor's Participation and Minister's Choice. Employers may offer it outside of those benefits packages, with the employer or the member paying the full cost.

The Long-Term Disability Plan offers financial protection for employees with a disability that surpasses 90 days, providing a partial monthly income throughout their disability. Employers may offer the plan to employees who are not enrolled in the Death and Disability Plan (which includes a long-term disability benefit) and are working at least 20 hours per week. Employers pay the full cost of coverage.

The Term Life Plan offers the same low-cost coverage available in the 2020 Benefits Plan. But in addition to a fixed amount of coverage (from \$5,000 to \$50,000), it includes a new feature — an income-based benefit amount, equal to one times a member's effective salary, capped at \$50,000. Under either option, employers pay the full cost of coverage.

The Board of Pensions' goal is for every minister and church worker to have access to quality benefits in support of well-being. The 2021 Benefits Plan advances on that goal while also enabling more ministers to access assistance and education programs designed to help them devote their best gifts to ministry.





#### REPORT OF THE COMMITTEE ON ADMINISTRATION

#### **INFORMATION:**

The Committee on Administration met on December 9, 2020 and January 20, 2021 via Zoom.

#### **ACTIONS REPORTED:**

- 1. Approved staff bonuses for the additional work required to move the Presbytery office in November.
- 2. Approved reimbursement to the Two Cents a Meal Program for salary costs covered during the eight week period of the Paycheck Protection Program Grant
- 3. Approved to pay only the amounts received from our churches towards the 2020 General Assembly and Synod per capita.
- 4. Approved in conjunction with the Presbytery Trustees to approve a second round of Paycheck Protection Program funding for no more than \$64,000.
  - A. Reviewed the request from Mission Committee for the second half budget for their committee. COA was not able to honor this request as covenant of intent information has not been received from all churches.
  - B. Reviewed the request from Mission Committee for approval of the three year CEDEPCA Memorandum of Agreement (2012-2023). As the current five year agreement is in place through December 2021, COA petitioned Cabinet to delay review of the Agreement to allow the COA time to assess the lasting financial impact the Pandemic will have on our churches.
  - C. Tabled the request of access to the 2020 Dismissal Fund allocation for the Mission Fund pending the Presbytery clarifying the original intent of the Property Settlement Task Force.
  - D. Requested Cabinet appoint a workgroup under the direction of the COA to clarify the intent and review the current allocation of the Dismissal funds. The suggested composition is two members each from Cabinet, Church Development, Administration, Discipleship, Ministry, Mission, Trustees and Transformation Team-a total of 16 members.

## **Summary of Actions for 2020:**

## Cooper House/Ukirk at Va. Tech

The Trustees provided funding of \$7,750 for repairs to the roof at Cooper House/Ukirk at Va. Tech.

## **Paycheck Protection Program**

The Trustees and Committee on Administration approved for the Presbytery of the Peaks to participate in the Paycheck Protection Program (COVID 19 relief effort). The Presbytery received \$49,500 from this program in 2020.

### **Radford Presbyterian Church**

The Trustees approved the request from the Radford Presbyterian Church to sell the church manse. The proceeds from the sale will be used to fund future minister's housing allowance and to make handicap accessible improvements to the church building.

## **Rustburg Presbyterian Church**

The Trustees approved the request from the Rustburg Presbyterian Church to sell the church manse. Proceeds from the sale will be used to upgrade the church facilities and support community ministries.

## **Presbytery Office**

The Trustees approved the lease of office and warehouse space for the temporary Presbytery office at 1195 Carters Stable Road, Forest, VA for a three year period. The proceeds from the sale of the Covenant Property will be set aside to provide a Presbytery office.

## **Covenant Church Property**

The Trustees (with the approval of Presbytery) entered into a sales contract for the Covenant Property with Providence Church. The \$850,000 sale of the entire property closed on December 21, 2020.

#### **RD Holmes Presbyterian Church**

At the November Presbytery meeting, the Trustees were named the Administrative Commission for the RD Holmes Presbyterian Church with all rights including original jurisdiction.

## West End Presbyterian Church

The Trustees approved the request of the West End Presbyterian Church to sell the church annex building for \$28,000. Proceeds from the sale will be applied to the purchase of a new boiler for the church building.
